1. SOCIAL

Nomination Fee	\$1,837.00	Annual Subscription	\$ 995.00
House Spending	\$ 500.00	Annual Clubhouse Redevelopment Levy	\$198.00

This entitles the Member to unlimited access to the clubhouse facilities. Access to golf course facilities is limited to **6 times per 12 months of membership**. Playing times are usually restricted to non-competition play for obtaining a handicap.

2. PROVISIONAL

House Spending	\$ 500.00 Annual Clubhouse Redevelopment Levy \$198.00

This category entitles the Member to unlimited access to the clubhouse facilities plus full privileges of the course on Tuesdays and Thursdays. The exception to this is that, during the winter season, all Provisionals in their first year of membership, on a handicap of 29 or more, must play after 9.00am in Tuesday competitions.

Provisional Members cannot play on men's competition days and any other specific days set aside by the Committee.

3. ORDINARY

This category entitles the Member to unlimited access to the clubhouse facilities plus full privileges of the course at all times during both Winter and Summer seasons except for men's competition days and any other specific day set aside by the Committee.

4. OTHER CATEGORIES

4.1 Student Junior

This category entitles the Member to access the clubhouse facilities in line with Liquor Licensing Laws. Access to the golf course is limited to Sunday mornings as well as specific hours outside of competition times. Play must be in the company of an Adult Member. Most Juniors begin as Student Juniors before moving up to the Junior category. This movement will be based on age, golfing ability and assessments conducted by the Club.

4.2 Junior

This category entitles the Member to access clubhouse facilities in line with Liquor Licensing laws plus playing privileges equal to a Provisional, with the exception that regardless of handicap, they can only play in the afternoon field of a Tuesday competition.

4.3 Country

Nomination Fee \$1,650.00 Annual Subscription \$ 840.00

House Spending does not apply to this category.

Annual Clubhouse Redevelopment Levy \$83.00

To be eligible, a person must ordinarily reside outside a radius of 100 kilometres from the Perth GPO and must not reside within this radius for more than one month in any year. If any Country member ceases to reside beyond that distance, she must apply to transfer to an alternative membership category. Country Members may play on the course up to a maximum of 31 days in each year, with no more than 5 times on any specific day of the week. Availability of the course is subject to normal access conditions. The Member also has unlimited access to clubhouse facilities.

3.4 Clubhouse Membership

Nomination Fee \$250.00 Annual Subscription \$280.00

House Spending \$500.00 Annual Clubhouse Redevelopment Levy \$198.00

Clubhouse Membership is offered to allow people, who, while not interested in playing golf, would like to become socially involved with the Club. Applicants would be required to undergo the normal new member entrance criteria and meet membership requirements in all respects.
